you and l'd like to thank all who have sent in their membership renewal forms and dues.
As I announced at the January bi-monthly meeting the folks at Friendship Force International (FFI) announced exchanges for 2016 and we were selected to spend two weeks in Russia, one week at Kirov and a follow-on week at Nizhnyy Novgorod (formerly known as Gorkiy). Both cities are located east of Moscow along the Trans-Siberian railway and are loaded with historical and important sites and places of interest. FFI has recommended the exchange occur in May, and I have written to both clubs but have not heard back from them as yet. As for hosting, we have been assigned to host ambassadors from the Medicine Hat, Alberta, Canada club. I have been in contact with the exchange director (ED) for their club and we are trying to work out when to schedule the exchange. The club will also be visiting the Hudson Valley, NY club. I know their preference is September/October which is a bit problematic as that could conflict with another exchange we will be involved with then.

I mentioned this in earlier Ambassadors but our participation in a multi-club Civil War-themed exchange is moving forward and to be honest is keeping several of us quite busy. The exchange includes clubs in Harrisburg, PA, Charleston, WV, Richmond, the National Capital Area, and us. AI Colville, Bob Schwagerl, newcomer Bing Spitler, and I currently are the FFCV planning committee for the exchange and Bing Spitler, a Civil War expert and author, will be ED. Planning for the exchange began in earnest in January and envisions a 19/20 day tour with up to 20 ambassadors touring such places as the battlefields at Gettysburg, Antietam, Manassas, and Fredericksburg area; museums in Harrisburg, Appomattox, and Richmond, Hollywood and Arlington Cemeteries, Ford's Theater, and numerous other Civil War-related sites. Right now it appears the exchange will begin in midSeptember 2016. We will have the ambassadors for four or five days and will be responsible for showing them sites in the Shenandoah Valley, battlefields in the Fredericksburg area, and historical sites in Appomattox. Our planning committee currently is trying to put together an agenda for these trips and we'll be meeting with reps from the other clubs in early April to work on the overall agenda. Although the exchange is well over a year away, all clubs will be running "rehearsals" of their tours throughout this coming summer which will be open to members of the other participating clubs. So if you've ever wanted to see Gettysburg or visit the Stonewall Jackson and Robert E. Lee sites in Lexington, this might be your chance.

I should also mention that the Santa Barbara, CA club still plans on having an exchange with us this coming October and at least count there are about 14 or so ambassadors planning on coming for what now stands at a five or six day homestay. The outbound ED for that exchange is away until the end of March, so those are the only details I currently have.

Finally, I understand there are still openings for those thinking about attending the FFI Northeast \& Mid-Atlantic Regional Conference in Portsmouth, NH on 17-19 April. Hopefully, you have seen the correspondence on this and as you've seen they have a very interesting program set up for us. This is a great chance to meet members of the other clubs in our region and also to hear Joy DiBenedetto describe FFI's new strategic plan and what it will mean to you. Right now, Bob and Dee Schwagerl and Linda and I plan on being there and we'd love for other FFCV members to join us.

## Have we Forgotten?

I would like to share two experiences that have happened recently, both having an imnpact on the health and growth of FFI.

As to the first, many of you in recent years have taken part in our club's efforts to attract new members. Much time, effort and advertising dollars have been spent telling the FFI story. As we look around the room during our meetings, we can see the new faces and be proud of our labors. At the same time, a few days ago, while in the supermarket, I met a long-time devoted member. When I mentioned I would see her at the next meeting, she advised me that she had left Friendship Force. She could no longer drive at night, she felt unable to participate in hosting and we lost a valuable member. Another couple left us because they felt unable to carry their own luggage. A couple, with a wonderful history of participation,left because of personal differences with someone in the leadership. The list goes on and on. As we reach out to new members through our "front" door, we lose many out the "back".

The second experience is sadly outside of our control that that is becoming aware of the passing of Jane Czarniak. Jane loved FFI and all of us loved her. While we cannot avoid our mortality and aging, we can ask our older members to rethink their membership and seek alternatives to resignation.

Our new leadership manual states our objective, to create "...understanding by bringing people together across the barriers that normally separate them." We state again and again, we are not a travel club. We are dedicated to a higher goal if we are not a travel club, then why does our ability to travel decide if we remain a member.

What makes FFI different and important? Our stories, our sharing, our building of relationships. Do older members have anything to impart to newer members? Certainly we do! We cvan all pass on what we have experienced. We can continue to share our stories regardless of age. Need proof? Ask for the recent CD prepared by Atlanta and listen to stories from all over the world. If we lose faith I the powr of our message then perhaps we have becomve only a travel club. Don't let that happen. Let's not forget the world we hoped to change through Friendship Force.

I have read the Ambassador Agreement provided with this Application and accept its terms. I hereby agree to secure adequate travel and medical insurance for the duration of the exchange. I certify that I am 18 years of age or older and have completed this application to the best of my knowledge and believe it is true.

[^0]Ambassador Fees paid. If an Ambassador cancels 60 days or less prior to the departure, FFI will not refund the ambassador fee paid. If FFI cancels an exchange, all Ambassador Fees paid will be returned to Ambassadors.
If this agreement is not for a club-to-club exchange, please consult your Program Coordinator for cancellation and refund policy. In case of cancellation due to illness or death of an Ambassador or an immediate family member, Friendship Force International may require a medical doctor's certificate and airline ticket to process the refund.
5. Friendship Force International may cancel this agreement if it is unsuccessful in establishing an exchange which satisfies the goals of Friendship Force International for any reason, including cancellation of or unacceptable changes to the airline arrangements or failure of the local committee to recruit the required number of Ambassadors. In such cases, the Ambassador Fee will be refunded except the $\$ 25$ portion designated as non-refundable.
6. If Friendship Force International is making travel arrangements for your exchange, any price increase for transportation will be passed on to the Ambassador until the time that the full Ambassador Fee is received at the international office of Friendship Force International in Atlanta, Georgia, USA. After that time, no increase will be passed on to the Ambassador, except in the case of carrier or routing changes beyond the control of Friendship Force International.
7. The Friendship Force Ambassador hereby agrees to follow the provisions stated above and: a) to attend training workshops, b) to accept travel arrangements as arranged by Friendship Force International, where applicable c) to participate fully in the home stay, d) to pay the Ambassador Fee when due, e) to accept the decision making authority of the Exchange Director during the exchange, and f) to accept that the exchange is a public event and that the photograph and name of the Ambassador may be used by the local and national media and Friendship Force International in its publications.
8. Upon acceptance of the Ambassador into the exchange program, this Agreement shall become effective and binding upon Friendship Force International and the Ambassador, and shall be governed by the laws of the state of Georgia, USA. No representations, or statements, whether oral or written, other than those contained herein, shall be binding on Friendship Force International. In the event the Ambassador fails to abide by any of the terms and conditions of this agreement, Friendship Force International may terminate this Agreement without any penalty or liability to Friendship Force International.
Ambassador Pledge: I agree to be an Ambassador of goodwill to the country I am visiting and I agree to live in the home assigned to me knowing that the standards of that home may be different from my own and that the host family has a culture or language different from my own. If home hosting is not available, I understand that I will be traveling for the purpose of extending friendship to the citizens of my host country.

## THE FRIENDSHIP FORCE INTERNATIONAL

## ARTICLE I


#### Abstract

Name The name of the organization shall be The Friendship Force of Central Virginia hereinafter referred to as the Club. This name shall not be changed unless permission has been obtained from The Friendship Force International, hereinafter referred to as FFI.


## ARTICLE II

## Purpose and Objectives

The Club is organized for the purpose of encouraging international friendship and understanding.
The following are the objectives of the Club:
A. To provide leadership and support for national and international cultural exchange programs. To provide continuity of Friendship Force activities through educational and cultural means.
B. To increase program awareness by disseminating information to Club members and to interested persons in the community.
C. To recruit members and maintain an active membership file.
D. To provide an orderly means of assembling and retaining pertinent records for use in establishing and assisting Exchange Committees.

The Club is not organized and shall not operate for pecuniary gain or profit. No part of the property of the Club and no part of its net earnings shall incur to the benefit of any private individual. The Club shall never be authorized to engage in a regular business of a kind ordinarily carried on for profit or in any other Club activity except in furtherance of the purposes stated above for which the Club is organized. The club shall never engage in attempts to influence legislation, or participate in any political campaign on behalf of any candidate for public office, nor shall any part of its property or any part of the income there from be devoted to such purpose.


#### Abstract

ARTICLE III

\section*{Members}

Section 1. Qualification: Club membership is open to any person who supports the goals and purposes of the Friendship Force and is willing to pay the required annual dues and agrees to abide by these Bylaws and Standing Rules \& Procedures of the Club. A member is in good standing having completed a membership


application form and payment of annual dues. Only members in good standing shall be entitled to vote and participate in club business.
Section 2. Annual Dues: The fiscal year of the Club is January $1^{\text {st }}$ through December $31^{\text {st }}$.
A. The Executive Board with the consent of the membership shall determine the annual dues.

Section 3. Honorary Life Membership: The Executive Board may award Honorary Life Membership, from time to time, to qualified members who over the years have demonstrated long term commitment to the goals of the organization.

## ARTICLE IV

## Officers

Section 1. Officers: The elected officers of the Club are the President, First Vice President, Second Vice President, Secretary, Treasurer and the Immediate Past President.
Section 2. Term of Office: Each officer shall be elected for a one (1) year term and may run for a second term, but the President may not serve more than two (2) consecutive terms.
Section 3. Vacancies:
A. A vacancy in the office of President shall be filled by the First Vice President.
B. A vacancy in the office of First Vice President shall be filled by the Second Vice President.
C. Vacancies in the offices of Second Vice President, Secretary and Treasurer maybe filled by the Executive Board.
Section 4. Duties: The Officers shall perform the duties as outlined in the Standing Rules \& Procedures manual.

## ARTICLE V

## Nominations and Elections

Section 1. Composition:
A. The Nominations Committee shall be appointed by the Executive Board at least five (5) weeks prior to the Annual Meeting.
B. The three (3) member Committee shall be chaired by the Immediate Past President, or in the event of a vacancy in this office, by an officer appointed by the Executive Board. The First Vice President shall serve on this committee and one (1) other member of the Club in good standing.
Section 2. Nominations:
A. The Committee shall prepare a list of nominees who are members in good standing and have consented to be nominated for a one (1) year term of office for the position of President, First Vice President, Second Vice President, Secretary and Treasurer.
B. The report shall be presented at the September Board Meeting or least ten (10) days prior to the Annual Meeting.
C. Nominations shall be accepted from the floor at the Annual Meeting provided that previous approval has been obtained from the proposed nominee.
Section 3. Elections:
A. The election of officers shall be held at the Annual Meeting. Elections shall be by voice vote; however, if there is more than one (1) nominee for an office, the election shall be
by ballot and shall not be cumulative. In the event of a tie vote, another ballot must be taken. The nominee receiving the majority of votes shall be declared elected.
B. Elected officers shall commence their duties on January $1^{\text {st }}$.

## ARTICLE VI

## Meetings

Section 1. Regular Meetings: The club shall normally meet every other month beginning in January, but not less than quarterly, on a date designated by the Executive Board
Section 2. Annual Meeting: The November meeting shall be the Annual Meeting. The President shall designate the time and place for the meeting. A written notice of the meeting must be sent to all members at least ten (10) days prior to the meeting.
Section 3. Special Meetings: Special Meetings of the Club may be called by the President, any three (3) elected officers, or any fifteen (15) members in good standing, with at least one (1) week's prior notice to all the members. Only the business mentioned in the notice may be considered at this meeting.
Section 4. Quorum: A majority of the voting members present shall constitute a quorum.

## ARTICLE VII

## Executive Board \& Board of Directors

Section 1. Composition: The Executive Board shall be the elected officers. The Immediate Past President maybe an ex officio member of the Board of Directors as a nonvoting member. Standing Committee chairs are expected upon request to attend Executive Board meetings as nonvoting members.
Section 2. Meetings: Meetings of the Executive Board shall be called as needed, by the President or any three (3) members with at least five (5) days notice.
Section 3. Quorum: Three (3) officers shall constitute a quorum.
Section 4. Duties: The Executive Board shall manage the business of the Club.
Section 5. Vacancies: Vacancies shall be filled by a majority vote of the Executive Board. an Executive Board member may be removed from his/her post by a majority vote of the Executive Board members.
Section 6. Board of Directors: The Executive Board may from time to time appoint nonvoting members to the Board of Directors.

## ARTICLE VIII

## Committees

Section 1. Types:
A. Standing Committees: The Standing Committees are Membership, Communications, Fundraising, Social, Exchanges, and Membership Outreach.
B. Special Committees: Special Committees may be called as needed.

Section 2. Term of Office: The term of office of Committee Chairs shall be determined by
the Executive Board.
Section 3. Duties: All committee chairs shall consult with the President, appoint members to their committee, present a list of members to the Secretary, call committee meetings when necessary, report activities to the Executive Board and at the Regular Meetings. The committees shall be governed by the duties as outlined in The Standing Rules \& Procedures manual.

## ARTICLE IX Parliamentary Authority

The rules contained in Robert's Rules of Order Newly Revised shall govern this Club in all cases in which it is applicable and which are not inconsistent with these Bylaws or Standing Rules that this Club may adopt.


#### Abstract

ARTICLE X Amendment of Bylaws These Bylaws may be amended at any regular or special meeting of the Club by a two thirds (2/3) vote of the members present, provided that the membership has been notified of the amendment at least ten (10) days prior to the meeting. The adopted Bylaws shall be submitted to FFI.


#### Abstract

ARTICLE XI Dissolution In the event of the dissolution of this Club to the extent allowed under applicable law, all of the assets of the Club shall be distributed to the Friendship Force, Inc., a nonprofit corporation, provided that the corporation is then in existence and is such a tax exempt organization. If FFI should not be in existence at the time of said dissolution, the assets of the Club shall be sold and the proceeds distributed to another organization organized and operating exclusively for charitable, scientific, literary or educational purpose which shall be determined by the Board of Directors of this Club.

The Ambassador Fee entitles the Ambassador to participate in a specific exchange and covers only the items specified in the itinerary. The schedule of payment of Ambassador Fees must be observed.
    2. The Ambassador recognizes that connected with any travel there are risks of loss, damage, and injury to persons and property, and the Ambassador is willing to assume and bear those risks. The Ambassador also recognizes that he/she is responsible for failure to comply with any law of any country visited. Therefore, the Ambassador, in consideration of his/her selection by Friendship Force International, agrees to and does hereby release, indemnify, and hold harmless Friendship Force International (which shall include the directors, officers, and employees thereof, as well as its volunteer workers) from all claims, actions, and causes of action based upon or by reason of any loss, damage, or injury to the Ambassador's person or property, arising out of or in any manner connected with any aspect of the exchange program or by reason of the Ambassador's failure to comply with any law in any country in which he/she may travel in connection with the exchange program. Friendship Force International shall have no liability or obligation to return the Ambassador to his/her home community if the Ambassador should miss the return trip due to illness, injury, failure to report to the airport at the prescribed time, or for any other reason.
    3. All Friendship Force Ambassadors are required to secure adequate travel and medical insurance to cover emergencies during the exchange. No travel, health, or accident insurance is provided by Friendship Force International, although one may be recommended. This requirement can be fulfilled through the Ambassador's existing insurance policy if it covers international travel, including emergency repatriation, or through a separate travel insurance policy. All travel will be subject to regulations and limitations contained in the ticket(s) issued to the Ambassador.
