President's Message

Of the many trips we have recently been on, one of the most interesting was our participation in the FFI Mid-Atlantic and Northeast Regional Conference held in Portsmouth, NH last month and I'd like to start off by saying a few words about that.

Bob and Dee Schwagerl and Linda and I represented our club at the conference and have to say we all had a great time, and it was especially nice to spend time with so many of our fellow Friendship Force members from almost all the clubs in our region. While there were a number of worthwhile topics and issues covered during the conference, the keynote speaker was FFI President and CEO Joy DiBenedetto who gave an in-depth presentation, via videolink, on FFI's new Strategic Plan for 2015-2018. included later in this Ambassador and I would suggest you take a few minutes to go over the document as there are a number of issues which will impact you as a member. Rather than describe the Plan I'm just going to highlight a couple things I think you might find interesting.

There is now a "Fill-the-Seat" policy in effect where every exchange that is not filled by a club will be posted on the FFI website 100 days before departure. In the past, basically only global, special, and FFI-sponsored trips were posted on the site. Thus, all of us will be aware of vacancies that all FF clubs have which will greatly expand options of where we can travel. If this appeals to you, I'd recommend you regularly check the FFI website to see what is available:

http://catalog.thefriendshipforce.org/index.php/catalog/all_list/. I would also suggest you sign-up for

email alerts from FFI, which is free, at https://app.e2ma.net/app2/audience/signup/79801/21753/?v=a
As I've mentioned in the past there also will be increased emphasis on short theme-based exchanges, which FFI calls "NextGen". The hope is these types of exchanges will appeal to those who cannot afford to be away for more than 3 or 4 days, and in the case of domestic exchanges will appeal to those who do not want or cannot afford to travel long distances. For example, in the future our club might be able to offer short home stays related to U.S. Presidents, the Civil War, wineries, or hiking and sightseeing in the Blue Ridge. So again, please go over the Strategic Plan and if you have any questions let me know. : Finally FFI provided several handouts, one of which is titled "So you Want to Be an Ambassador", which provides some basic but good tips for those who want to travel; it is included later in this Ambassador.

Another issue I would like to emphasize is our becoming a formal non-profit organization (IRS designation 501C3). As I have mentioned in the past, Rob Beck volunteered to lead the effort in analyzing the pros and cons of doing so, and if found to be positive for the club, to come up with a plan of execution. The bottom line is Rob has done a lot of work on this subject and has briefed your Board of Directors (BOD) twice on his findings, which he found to be highly favorable for the club. As a result, the BOD approved going forward with the plan to achieve non-profit status and incorporating the club with its existing name, recognizing the FFCV membership will have to agree to do so via a formal vote. A version of Rob's briefing to the BOD is included in this Ambassador and I hope you will read it carefully as you will be asked to vote on this issue in an upcoming bi-monthly meeting.

In terms of incoming and outbound exchanges very little has changed since the last Ambassador. We are still scheduled to spend two weeks in Russia next year, and I have requested this happen during the summer months. I have not heard anything from either the EDs there or FFI, so unsure what the status of the exchanges are; will pass this on once I hear something. As for inbounds, I recently heard from the ED for the Santa Barbara club and they plan on arriving here on October 7th, and being here for 5 to 7 days. The number of ambassadors currently is unknown, but with the aforementioned "Fill-the-Seat" policy in effect we could be hosting up to 20 ambassadors. Paul Hokanson will be our ED for this exchange and we will be looking for hosts to come forward in the next couple of months. We are still on the hook for hosting a group from Medicine Hat, Alberta next year, but when this will occur remains up in the air. The other club, Hudson Valley, NY, that was going to host that club before or after they visited us just cancelled their participation so we will have to see what happens. We have asked for the exchange take place during the summer months.

The Civil War-themed exchange we will be sponsoring with four other clubs has been approved by FFI and will occur in September, 2016. The itinerary for the exchange is included later in this Ambassador but in summary we have hosting responsibilities for four days and five nights with one day a "free day" with optional tours, a day to the Shenandoah Valley, a day to the battlefields near Fredericksburg, and a final day at Appomattox. We will need to pick up the ambassadors (no more than 20) in Staunton and have to transport them to Appomattox; buses will be used for the Valley and Fredericksburg tours. Hosts who provide transportation from Staunton and to Appomattox will be compensated for mileage and meals. Those of us involved with planning this exchange will be running "dry run" tours throughout the summer; if you are interested in participating please let me know.

Finally, I'd like to thank my wife Linda who is chair for the program, and all of you who are and have sponsored foreign Judge Advocate General (JAG) officers over the years. Your recognition by the JAG School leadership as Linda has written is well deserved. As all of you know, JAG foreign officer sponsorship is something we as members of FFCV have strongly supported for over 16 years now and I applaud all of you who have been involved. Great job folks!

IRS 501C3 OUALIFICATION PROJECT

CURRENT STATUS OF FFCV

- 1. <u>Unincorporated</u>, Virginia, not-for-profit entity.
- 2. **Chapter (franchise) of FF International** (Atlanta, GA.).
- 3. <u>501C4 charity "Inferred"</u>: FFCV is a chapter of FFI in good standing for more than 10 years and has received an IRS EIN number indicating it is engaged in charitable work.
- 4. Revenue & Assets: Historically Annual Revenue has been under \$25,000 and Net Assets under \$250,000.
- 5. <u>Programs are Educational</u>: Programs include participation in short term living experiences for US persons within the USA and abroad; and, for Non-US persons within the USA. Members act as local volunteer hosts and educators to visiting this area of the USA. Members act as unofficial ambassadors of good will to people visiting the USA and when in exchange groups visiting abroad. FFCV is especially effective in this good will and education function due to its years of providing hosts and mentors to foreign students attending the JAG National Education Program based in Charlottesville, Virginia, (See the FFCV brochures and marketing material).
- 6. <u>Records & Administration:</u> FFCV historically and currently maintains complete financial records, financial statements, and business records (e.g. board of director minutes) for its operations and has maintained for years revenue and assets in excess of expenses and costs.
- 7. **No Tax Deductions:** FFCV is not an approved IRS 501C3 corporation and therefore donors, sponsors and other supporters cannot deduct funds, assets or services provided to FFCV as deductions against their Federal or state income taxes.

BACKGROUND OF IRS 501C3 PROJECT

1. FFI now encourages chapters to seek 501C3 status.

- 1.1. Historically FFI has not been willing to be a 501C3 charity or to assume responsibility for its chapters.
- 1.2. FFI is now a 501C3 charity, but is still not willing to assume responsibility of its chapters sufficient for them to be 501C3 subparts of FFI. (Our guess: FFI does not want to assume possible legal liability for the operations of its chapters since the FFI has little control of chapters.
- 1.3. FFI national website now has encouraging language and forms to aid in requests of 501C3 status of chapters.
- 1.4. FFI appears to recognize the benefits of 501C3 status

2. 501C3 Status Provides Real Benefits:

- 2.1. <u>Donors</u>, sponsors or other contributor's deductions against Federal and state income taxes.
- 2.2. <u>FFCV volunteers</u> are generally more mature individuals with apparently higher income tax brackets than other, similar, organizations. 501C3status would permit such volunteers to take part or all of their donations of money, assets in kind, and out-of-pocket expenses made to or on behalf of FFCV. (E.G. Out-of-pocket expenses made by exchange sponsors or related to FFCV events.).
- 2.3. Provide a much <u>broader target audience</u> of fund raising. Sponsors are more often more willing to budget funds, product or services to a 501C3 organization because they can take tax write offs beyond just cash donations.
- 2.4. Apparently, some organizations with which FFCV has dealt <u>mistakenly believe</u> FFCV is a 501C3 organization.
- 2.5. FFCV with a <u>more stable structure and operating environment</u> which aids in keeping FFCV a viable organization into the future.
- 2.6. <u>FFCV has in place the financial and related records and reports required by the IRS for 501C3 status.</u>
- 2.7. FFCV revenue and assets are well under the IRS minimum requirements for full Form 990 filings. FFCV can use simple, on-line, computer reports to meet IRS and Virginia annual filing requirements. Therefore, there is not significant increase in administration of FFCV as a 501C3 corporation.

2.8. <u>FFCV has \$1,000</u> to spend on this project. Cost usually \$3,000 to \$5,000. Substantial saving to go at this time. Future annual operating expenses attributable to maintaining 501C3 status estimated to be \$100.00.

Strategic Plan 2015-2018

Setting FFI on a Sustainable Course

For 38 years now, the Friendship Force has shown that peace and harmony in the world can be cultivated through individual friendships. This milestone bears witness to the enduring relevance of our mission and to the time, energy, and talents each of us devotes to the organization we love. Celebrating those achievements and securing our legacy for the generations to come must now be our unwavering goal.

This Strategic Plan is a response to your recent input on two conclusive sets of documents. Chief findings of the June 2014 surveys showed that 83% love home stays but want lighter tasks for hosts, while exchange participants want more learning, more meaning through action, more diversity, and more flexibility. The more recent policy review endorsed new policy directions and confirmed that club members are willing to embrace inclusiveness in order to set FFI on a sustainable course.

With your full endorsement, this Strategic Plan sets out a vigorous revitalization and sustainability agenda for FFI. What you see below is an executive summary. Defined in numbers, these overarching goals are designed to increase participation in exchanges by 10% over the next three years. This ambitious goal will require full engagement in the activities of the organization.

1st Initiative: Enrich Friendship Force Exchanges:

Revitalize exchanges through:

DIVERSITY: New clubs, thematic exchanges and partnerships in high-demand destinations. MEANING: Through "Friendship in Action" exchanges with a variety of humanitarian components.

LEARNING: Language learning, professional development, and education exchanges. FLEXIBILITY: New models, new exchange structures; a more flexible fee structure; a more casual exchange approach for club members, with more "time on your own" and program options with varying prices and degrees of physical challenge.

2nd Initiative: Maximize Exchange Participation & Hosting Capacity:

Friendship Force is all about people meeting people. With this mission in mind, it remains our goal to involve more people as both ambassadors and hosts.

FILL-THE-SEAT POLICY: Beginning April 2015, post undersubscribed exchanges on the FFI online exchange catalog 100 days before departure. Priority to regional clubs and local communities is encouraged.

ONLINE MEMBERSHIP: Beginning January 2016, introduce an e-membership component and a new vetting process.

Launch a consultative process involving creative leaders to deal with declining hosting capacity in Europe, establishing footholds in challenging/emerging destinations, and making use of surplus hosting capacity in the USA and Pacific region.

3rd Initiative: NextGen for Everyone:

NextGen is not about age, it is a state of mind.

Develop NextGen exchanges for active people who seek more involvement, more adventure, and more freedom.

Target active, existing FF participants as well as soon-to-be-retirees and younger generations.

4th Initiative: Leadership Development:

Add field reps where most needed.

Create task forces on a variety of topics.

Encourage clubs to embrace a goal and report progress.

Offer frequent and accessible training from FFI to learn new models, new tools and technology and new skills to reach out to our communities.

Add a one-day component of leadership development to regional and national meetings.

5th Initiative: Branding & Marketing:

Develop a new promotional video.

Initiate a global friendship program.

Include clubs and members in fun global and local community projects and events---such as photo contests and exhibitions---that will raise awareness.

Create opportunities to participate in select high profile, newsworthy events such as the Nobel Prize Laureate festival being held in Atlanta, November 2015.

6th Initiative: Leverage Modern Technology:

Build a new information database with improved functions for member services.

Develop a global online community platform and website.

Improve the usability and functionality of web applications for members.

7th Initiative: Partnerships:

Increase program variety and participation through partnerships with:

Like-minded organizations that share complementary missions.

Revenue generating partners including hospitality suppliers and travel operators, such as cruise providers and land expeditions, which will benefit FFI and its members. Encourage clubs to explore potential collaborations in the in their own communities.

8th Initiative: Enhance & Secure Revenue Streams:

Define the precise purpose and use of FFI fundraising – this will attract new and diverse donors.

Introduce a digital fundraising platform that will also produce more FFI exposure.

Explore potential for funding through grants.

Link campaigns and partnerships for specific programmatic fundraising purposes.

Formulate an endowment plan.

Continue yearly application for Open World grants.

Taken together, these bold measures will provide the revitalization and financial stability required to secure our legacy for ourselves and for the next generation. These measures and initiatives will require both a dedicated commitment to our collective mission, and a business approach to managing expanding programs in a manner that is financially sustainable.

What's in it for me?

Your roles & responsibilities: 1. Guest, 2. Ambassador, 3. Traveler

1. Guest:

- ---You will live for 5-7 days with a local host family, learning first-hand about the host culture.
- ---You will become a part of that family, and share everyday responsibilities
- ---You should be physically able to walk to a local market, climb steps, travel on public transport.
- ---Living accommodations vary, be flexible, be accommodating, be understanding---be a good guest.
- ---Lodging and meals in the home are provided by the host, but they are not your servants, pitch in.
- ---Being a good guest means expressing gratitude, bring a gift for your home host, bring small gifts for day hosts and host dinner, write a thank you note at the end of the exchange (bring a note card with you)

2. Ambassador:

- ---You go as a representative of Friendship Force, your country, and your community. Reflect the best on their behalf.
- ---Learn about their country and share about your own.

- ---Go prepared to show your very best, be a true ambassador.
- ---Be open, be tolerant, be respectful.
- ---Be prepared to participate in ALL host club's programs.

3. Traveler:

---With local citizens as guides, the ambassador is introduced to the best attractions of the region. Have a spirit of adventure, flexibility, and be open to new experiences.

What can you do to make things run smoothly?

- ---Attend all meetings for your exchange.
- ---Don't put off for tomorrow what you can do today. It takes time to get a chip card, establish a phone plan, make copies of your itinerary, passport, IDs.
- ---Be on time, your group is waiting for you; be first, not last.
- ---Be flexible; don't have expectations, you may be pleasantly surprised.
- --- Pack light; you will have to carry it, your host may not have a lot of room.
- ---Write and get to know your host as soon as you can.
- ---Narrow the gap, cross all boundaries, make a friend.

<u>Communicate:</u> Any problems or concerns, from initial contact with your home host to the end of the exchange, ALWAYS first line of communications is with your ED.

For Participation: Fill out and send all application forms and requested materials to the ED in a timely manner; be sure to acquire travelers insurance; make sure passport is up-to-date.

FINALLY: ENJOY, HAVE FUN, MAKE WONDERFUL MEMORIES & NEW FRIENDS.

Our First Friendship Force Exchange(s)

We joined Friendship Force about 3 years ago with the hopes of traveling and meeting new people. After hosting and day hosting several couples, we decided to take our first outbound trip last fall. Of course this was not a hard decision because we had always wanted to go to Australia; New Zealand was an added bonus. We had heard that you needed to see both the north and south islands of New Zealand so we began planning with other members from our club who were participating in this exchange. All we can say now is that this trip was one of the best experiences of our lives. It was beyond all expectations!

We knew little about New Zealand and WOW what an incredibly beautiful country – from rain forests to glaciers. We started out in Blenheim – Marlborough wine country, absolutely beautiful and the Sauvignon Blanc was some of the best we've ever tasted. We visited Christchurch, Greymouth, Queenstown, Franz Josef Glacier, Milford Sound, and Dunedin in the south island. Each city of course had its own flavor. Damage from the earthquake was still evident in Christchurch, but also was the resolve of the people to rebuild. We traveled by plane, train, and bus along seacoast and through the mountains. Buses and cars traveled on the "wrong" side of the road, which took some getting used to, but the narrow roads (some with sheer drop-offs along the side) and many one lane

bridges were a little unnerving – just glad we didn't have to drive. The New Zealanders called themselves "Kiwis", and were the friendliest people I've ever met. We went on to the north island - Auckland and Keri Keri and the Bay of Islands. Again breathtaking beauty! It was an incredible 10 days before we began our homestay. It was their spring and everything was so green and the flowers and shrubs were absolutely beautiful. We saw plants we recognized and saw new and different ones. It was lambing season and it was fun to watch the baby lambs frolicking in the fields. Our host family lived on a hobby farm and two lambs were born while we were there. New Zealand has 4 million people, but 40 million sheep. Our hosts were new to Friendship Force and we were first time hosts. Their club had many activities planned for us keeping us busy and well fed. We enjoyed meeting and interacting with the club members and it truly was a wonderful experience. While we were out at one of the museums, we ran into a couple that had hosted Walt and Patsy O'Connell – small world!

After 3 incredible weeks in New Zealand we are off to Australia for another homestay in Tamworth, the country music capital of Australia. This time our hosts were long time members of Friendship Force and experienced hosts as well as planners of the many activities. They also kept us busy and well fed. The weather was hot and dry, reminding me of Arizona. We also saw different trees and shrubs. I loved the purple jackaranda trees. We also saw many kangaroos and got to pet koalas – a real highlight. The birds were extremely colorful. Again an incredible week! We topped it off by spending 3 wonderful days in Sydney. The harbor was beautiful and never stopped – day or night. We visited the Rocks, Bondi Beach, and had an amazing tour of the opera house. This truly was a trip of a lifetime!

Every trip is an adventure and this one was no exception. First of all the relationships we formed and friendships made were the best part. We got to know members of our own club so much better and truly shared experiences and fun, much of the time with a glass or two of wine. We also learned Linda Gehle graduated from Valparaiso University a couple years ahead of us. We also learned a few practical things too. It was difficult packing for 5 weeks that involved every change in season hot and cold. New Zealand airlines are very strict about the weight limits of your luggage — we had our carryon luggage weighed at every airport. 


