DISCOVER MONGOLIA; GLOBAL EXCHANGE TO FF OF ULAN BATAAR, MONGOLIA AND ULAN UDE, BURYATIA, RUSSIA July 9-31.

Join a fascinating exchange to Ulan Bataar and Ulan Ude, two closely related, yet distinctly different cultures in the Russian Far East and Mongolia.

I decided to go, and since I had to change planes in Seoul, Korea, I decided to leave early and spend 5 days there to have a look around. I arrived in Ulan Bataar (UB) on July 8 and was met at the Genghis Khan airport by the son of a FF member who drove me to "The Best Hotel" where our group was to meet. We were 13 in number and came from Belgium, UK, Australia and the USA. Our Exchange Director was a FFI consultant who worked in Atlanta. We were rather surprised by the hot (100 F) weather.

Next morning some Mongolian FF members delivered 'breakfast boxes' to our rooms and then accompanied us to exchange money and take us to lunch. We were asked by Boyar, the Mongolian ED if we were interested in going to a special party to celebrate the opening of the Nadaan Festival at \$40 per ticket. We all agreed and were picked up by a mini-bus that evening. The event was held in a Buddhist temple located among skyscrapers in the city center. The guests were VIP's of UB and all were very well dressed, while our FF group looked like refugees from a third world country, dressed in tee shirts, jeans and sneakers. I met Piper Campbell, who is the US Ambassador to Mongolia. Tables were laden with wonderful food and drinks and a tour was given in English regarding the temple treasures. We were entertained by a band of 'throat singers' who played ancient Mongolian musical instruments and sang, there were dancers, singers, and contortionists. We returned to our hotel at 1 AM.

The following day we all went to a restaurant for lunch to meet our hosts. Lunch consisted of platters of Mongolian foods for us to try. There were buuzi (meat dumplings), beef, a chittlin-like dish, horse meat as well as beer and wine. We were entertained by a singer and after lunch went home with our hosts.

My hostess was a female MD who was a deputy director of the Mongolian CDC and spoke practically no English. The following morning we went to Nadaam, the most important festival in the Mongolian year for the opening ceremonies held at a stadium. The Nadaam festival consists of the Mongolian national sports of horse racing (15 to 25 miles straight) archery and wrestling. The Harvard educated president of Mongolia gave the opening address followed by displays of marching, dancing and music. Many families were dressed in traditional Mongolian clothes and atmosphere was very festive. There seemed to be few cars in UB as everyone left town to be at the finish line of the horse race. The crowd there was huge and the wind was fierce and blew sand in our faces. The finish line was not visible and our group was invited to the family yurt of my hostess's brother. The yurt was beautiful with hand carved furniture, a big flat screen TV and fine carpets. Solar panels and a TV dish stood outside the yurt. A feast was waiting for us! I drank airag, fermented mare's milk, from a sterling silver cup.

Our program included visits to temples and museums and later we took light backpacks, boarded a minibus and drove into the countryside. It rained a lot and once we were off the highway, the roads were unpaved. We stopped at a 150 foot stainless steel statue of their great national hero Genghis Khan, whose empire covered all of Siberia, China, India, Iran, Russia and extended to the gates of Vienna. Driving through the countryside we saw the vastness and beauty of the Mongolian steppe, the rugged granite mountains, the high sand dunes, scattered yurts of the nomads, herds of livestock, horses, sheep, goats, yaks, camels and some wild life. We stayed in comfortable yurts for two nights and then returned to UB for one day and the next day we were off to another yurt camp. We stopped at a 13th century theme park where we saw, a Shamans camp showing Shaman's yurts from different regions of Mongolia, typical nomadic herder's yurt, followed by a lunch in the Khan's Tent where we were entertained by musicians and a singer in costumes from the 13th century. We also visited Karakorum, the site of Genghis Khan's ancient capital. We also saw an archeological site with a museum housing relics of 6th century Turkic tribes. A visit to a yurt of a nomadic herder and his family, where the traditions of the past are still practiced, was also included. After our 2 night stay in a yurt camp on the shore of Lake Oqii, we stopped to see the Takhi horses (aka Przewski horses) the original wild horses thought to be extinct but now were being slowly bred into existence. After returning to UB we toured the summer and winter palaces of the last Khan and attended a cultural performance filled with traditional singers, dancers and musicians. Our farewell party was held in a pizza restaurant and the next evening we sadly departed for the Trans-Mongolian RR to Russia and our next 10 days of hosting.

Our train ride lasted 26 hrs. We were stopped at the Russian border for 5 hrs. for inspection. Some of us got off the train and found a small stand that sold fruit and other food to take with us, since only hot water was available on the train. All our compartments were 4 passengers with upper and lower bunks and very fresh white linens.

The Buryat people, though Mongolian in heritage and ethnicity, have been part of Russia for about 300 years, and thus are an interesting blend of eastern and western cultures. We arrived in Ulan Ude after dark and were met at the station by our hosts. My hostess was a retired engineer/economist who had studied English in school abut did not speak it.

Since my hostess did not drive, we had to take the small buses which serve the city. After a walking tour of the city, we visited Ivolginskogo, the center of Buddhism in Russia where we ate a lovely lunch and each one of us was ceremoniously presented with a yellow silk scarf. That evening at a lavish 'welcome party' in a restaurant, we were entertained by a family of "Old Believers" who sang old songs from the 17 century and before.

Our group traveled everywhere by mini-bus. We toured an Ethnographic open air museum which included various houses of the "Old Believers", as well as 17 century homes of prominent citizens, and a museum. The next day we visited a Buddhist nunnery. One evening my hostess took me to the suburbs to stay at a friend's house where I unsuccessfully tried my hand at making buzzi. We went home the next morning with bags of fresh vegetables from her friend's garden. We drove to Lake Baikal for an overnight stay. The lake is over a mile deep and holds as much water as all of our Great Lakes. We stayed a rustic resort, ate fresh fish, and had a great time. Upon returning to Ulan Ude we visited an old neighborhood of Russian style log houses and markets. We viewed old icons in a Russian Orthodox Church, where the casket containing the corpse of an old lady was brought in for a funeral service.

Another day was spent with a female Shaman. Our hosts gave us scarves to cover our head and legs and Tatiana, our Russian ED, brought paper, chocolate, cookies, vodka and ariag for the ceremony. The Shaman was a well-nourished woman, dressed in an elaborate robe, which fed a fire with the offerings and conducted a ceremony accompanied by the 3 men in our group. We women stood in the shade as it was also very hot in Buryatia and made wishes for our families. Many Buryatia's are believers in Shamanism.

We were also toured an art museum, a natural history museum, their beautiful opera house as well as a few Buddhist Datsans. Our farewell party was held in a restaurant and after many toasts by our hosts and us, we were also presented with gifts. The following morning we departed for UB.

After arriving in UB in early morning we were again met at the train station and taken to our hotel. We were picked up at noon and taken to one of the UB FF member's apartment where a very lively lunch was prepared for us. The men and women made 3 kinds of soup, roasted fish, pork belly, chicken, beef dishes, buzzi, salads, fruit platters and vodka. They sang Mongolian songs, then we all sang Frank Sinatra songs (karaoke is very popular) a little of Springsteen and we all danced in the kitchen. A good time was had by all. Back to the hotel for a few hours, then on to the airport for a flight home. We were all very impressed by the generosity of these Friendship Force Clubs....we practically did not pay for anything. Their members accompanied us and provided all transportation. The Mongolian FF had many young members who spoke English very well and accompanied us everywhere, even to the countryside. The exchange lasted 10 days in each place and it was the most interesting and funfilled exchange that I have ever been on!

Serving as a Home Host?

Friendship Force Long Island (Edited for FFCV)

The most important thing to remember is that you are hosting Friendship Force members who share the same interest in learning about different cultures. They will surely enjoy their trips to the beach, museums, and nearby attractions, but meeting your friends and family and understanding your lifestyle will enrich their travel experience. Hosts might consider taking them to their place of worship, the grocery store, the library or even the post office. Walks through your neighborhood, bike rides, or a backyard barbeque with neighbors --- these everyday experiences might be the best memories of their visit to your club.

A home host provides a comfortable bed, preferably in a private room, for an ambassador throughout the duration of an exchange. You may opt to host either a couple or a single person, and may specify if you prefer to host a woman, a man, or either.

In addition to providing a place to sleep, as a host you are responsible for *providing* breakfast daily---providing, <u>not serving</u>. Remember, you are not a B&B. Ambassadors are to be treated as if they were a member of your family. They are expected to serve themselves, clean up after themselves, and to assist you.

Organized activities are pre-planned by our club for most of the days of an exchange. You have the option of accompanying your ambassador(s)---with the entire group---on any or all of the days. The ambassadors have prepaid for their activities. You will need to do so, in advance as well. You are encouraged to participate in as many of the daily activities as possible, though keep in mind that this can cost you up to a hundred dollars. The more you participate, the stronger the bond you will create with your ambassadors.

If you choose to opt out of any of the day's activities, you <u>must</u> inform the day host coordinator (prior to the exchange), and a day host will be assigned to take your place. It is advisable to introduce your ambassadors to their day hosts at the welcome dinner or whenever possible at the earliest time. If you are hosting a dinner in your home, you are encouraged to invite your day host(s). It is also an opportunity to introduce friends and family to your ambassadors. It is an excellent way to expose them to the world of Friendship Force.

Expect to be asked to provide a bag lunch for your ambassador(s) for several of the days during the exchange. It is fun to involve them in preparing the bag lunches assembly line style. It is also an experience to bring them to a supermarket to select the food for the bag lunches.

Our exchanges traditionally include a welcome dinner, a farewell dinner, a mix/match dinner and maybe a dinner at a local restaurant. If you are home hosting, one member of your household is entitled to attend, at no charge, either the welcome or farewell dinner. (The ED will decide if this is one or both). It is also customary for ambassador to treat you to dinner or lunch one day during the course of the exchange.

In many exchanges, but not all, one of the exchange days is called a "free day". On that day, only, you and your ambassador(s) may choose to either stay home and relax, or explore a place of mutual interest together. Be flexible. Keep in mind you are representing the USA and your club and you want them to have a positive experience.

It is customary to exchange small gifts (preferably made in the USA) with you ambassadors. Suggested gifts: a picture book of the local or state area, handmade crafts, a tea towel printed with a map of the local area or state, a club baseball cap, or other memorabilia from the local area. In addition to any gifts you provide to your ambassadors, the club will put together a bag with various mementoes, pamphlets, maps, etc.

How Do I Make an Ambassador Comfortable?

It is very important to communicate with your ambassador(s). Once you receive the "match" from your ED, contact the ambassador by email (or snail mail) to invite them to your home. It is customary to tell them about yourself in this introductory email. You might want to attach pictures of yourself and your home in the initial email. If you don't hear from them with a reasonable amount of time, try once more. If you still receive no response, communicate this to the ED.

When you communicate with them, ask them about special interests so that you can plan the free day activity in advance. Let them know if you have WIFI in your home. And let them know whether or not they will be able to use your washer and dryer. It will aid them when they pack for the trip.

Be Sure to Ask Your Ambassadors about Allergies and Physical Limitations

Though they should have, they might not have listed these on their applications. It is also customary to ask them about their food preferences as it relates to breakfasts and lunches. If they are willing to experiment, introduce them to regional foods such as barbeque, fried chicken, etc.

If you have pets let them know what and how many you have. They should have noted any allergies or problems with pets on their applications but you want to make sure this will not be a problem.

Once they arrive at your home, give them a tour. They will be curious about your home, garden, neighborhood, etc. especially if they are from a foreign country. Show them to their room and give them privacy so they can settle in. If it is early in the day, this would be the ideal time to take them to your local supermarket.

At a supermarket let them know what you and the club plan on providing for the week and ask if there are any other items they would like to purchase for the time they will be staying with you. You might also want to ask if your ambassador likes beer, wine or other alcoholic beverages and tell them what you can provide and if they want anything else you will take them to a place where they can purchase them.

After the first breakfast, give them a tour of your kitchen; showing them where the breakfast food is, where the plates, cups, etc. are, and how to operate the microwave, the toaster, coffee maker, etc. Most Friendship Force members understand they will be on their own for the rest of their stay, unless you offer a special hot breakfast, i.e. bacon and eggs, or other option. Again, remember you are not expected to be a B&B.

After a busy day's activities, take your cues from your ambassadors. They will be with you 24 hours a day. If they need "space" and alone time, so be it.

Have fun sharing your community, your country, and your culture. Compare and contrast differences and similarities. In our area, a trip to Walmart, Costco, and even Lowe's are an adventure. If they

like to garden, a trip to a local nursery will fascinate them. An avid reader would love to visit your local library or one of the many bookstores in and around Charlottesville.

Home hosting need not be complicated. Above all, relax and enjoy this unique experience of learning about another culture or part of our country, and sharing your lifestyle with them.



The CLUB president is hereby authorized and directed to offer all of the assets, operations, and on-going business of the CLUB of every Nature and kind to FFCV, Inc. for the purpose of carrying on the charitable purposes and operations of the CLUB within FFCV, Inc. This offer shall be deemed accepted by FFCV, Inc. and the transaction completed upon the acceptance of the offer by the Board of Directors of FFCV. Inc. on whatever

the positions and terms in office of all current Directors and Officers of the CLUB shall be terminated and all
operations of the CLUB shall be terminated and passed to CLUB, Inc. The Resolution was adopted.

<u>Call to Order:</u> David Burns acted as Chairman of the meeting. Rob Beck, then by Margaret Dryer, acted as Secretary of the meeting. The Secretary announced that a quorum was present.

The Chairman called the meeting to order at 9:30am. All actions taken by the BOD were done upon motion duly made, seconded and followed by discussion, and carried by a majority vote of the Directors unless otherwise noted.

1. <u>Transfer of Friendship Force Central Virginia (an unincorporated Virginia charitable organization referred to as the "Club") assets and operations into Friendship Force Central Virginia, Inc. (FFCV,Inc.)</u>

Accepted and Approved.

Background. Messer D Burns and R, Beck presented this matter to the BOD. The Club has been operating for some decades as a Virginia unincorporated organization independent franchise chapter of the Friendship Force International ("FFI"). The Club's initial name was "Friendship Force of Charlottesville, Virginia" which name was changed to the current Club name. The Club wishes to transfer all its assets and on-going business and operations into the FFCV, Inc. as part of the consideration and plan to convert the Club into an organization capable of securing status as a Federal Internal Revenue Service 501C3 qualified charity.

The Club, by its board of director action on July 15,2015 authorized the Club President to present an offer on behalf of the Club, to transfer all Club assets, business, and operations to FFCV,Inc. Mr Burns presented the Club offer to the meeting. A copy of the July15,2015 Club board of directors action, certified by the Secretary of the Club, was ordered attached to the minutes of this meeting and made a part thereof.

<u>Actions.</u> FFCV, Inc. hereby accepts the offer of the Club to receive all the assets, business, and operations of the Club under the following terms and conditions;

- 1.1. This transaction shall include any and all assets whatsoever of the Club as of June 30, 2015 and shall include, but not be limited to all cash, investments, receivables, revenue and assets disclosed on the Club Balance Sheet at June 30, 2015, the Club Statement of Income and Expenses for the period January 1, 2015 through June 30, 2015 (copies of which, Certified by the Treasurer of the Club, are ordered to be made a part of these minutes); all tangible an intangible assets including Good Will, the Club Internal Revenue Service EIN Number 55-791440; all trademarks, trade-names and related assets; and the Club membership charter with FFI. And all Club/FFI memberships and related assets.
- **1.2.** The date of this action shall be the date on this meeting, but the effective date of the transaction shall be June 30, 2015.

1.3. The FFCV, Inc. Chairman of the BOD and all other Directors are hereby authorized and directed to take any and all actions which they each deem appropriate, including the expenditure of FFCV, Inc. funds, to complete this transaction without further approval or action by FFCV, Inc. BOD. **Actions 2.1., 2.2.,and 2.3. were adopted.**

2. <u>Directors of FFCV, Inc. Appointed.</u>

The following individuals are hereby immediately confirmed or appointed as the Directors of FFCV, Inc. for a term of office beginning on July 15, 2015 until December 31, 2015 or until their successors shall have been appointed and assumed office.

5. Banking and Check Signing Authority Approved.

- 5.1. The BOD shall approve the opening, or administration of all bank or related financial accounts and in such approval shall authorize the Treasurer, Assistant Treasurer, or such other Officer of FFCV, Inc. to take whatever actions may be needed to carry out the BOD action.
 - 5.2. Check writing authority shall be as authorized and delegated by the BOD as follows:

Checks up to \$500.00 One (1) signature of the Treasurer or Assistant Treasurer.

<u>Checks over \$500.00</u> Two (2) signatures of the Treasurer and any other Officer.

President Burns chaired the remainder of the meeting.
